The assigned judge is requested to commence these hearings at 8:15 a.m. on holidays and weekends. **The Judge should call in advance to determine the need to hold hearings - 534-7090.**

2. First Appearance Hearings on holidays and weekends are conducted at the Polk County Courthouse in Bartow commencing at 9:00 a.m. Please be on time in order to hold to a minimum the hours of overtime for support personnel.

3. Regular weekend duty hours are from 5:00 p.m. Friday until 8:30 a.m. Monday. Holiday weekend duty shall begin at 5:00 p.m. on the last regular working day and conclude at 8:30 a.m. on the next regular working day. Isolated single day holiday duty shall begin at 5:00 p.m. on the preceding day and conclude at 8:30 a.m. on the day following the holiday.
