**SPECIAL ORDER**

**ADDITIONAL ASSIGNMENT OF CIRCUIT AND COUNTY JUDGES  
TO THE OTHER COURTS OF THE TENTH JUDICIAL CIRCUIT**

**WHEREAS**, it is necessary for the dispatch of business in the Circuit and County Courts in the Tenth Judicial Circuit for the following assignments to be made.

**NOW, THEREFORE**, I, J. 2. Judges Abdoney, Coon, Flood, Green, Griffin, Harlan, Kaylor, Kirkland, Ojeda and Williams to the Circuit Court of the Tenth Judicial Circuit and to the County Courts in Hardee and Highlands Counties.

3. Judge McKibben to the Circuit Court of the Tenth Judicial Circuit and to the County Courts in Highlands and Polk Counties.

4. Judge Ritenour to the Circuit Court of the Tenth Judicial Circuit and to the County Courts in Hardee and Polk Counties.
