SPECIAL ORDER

**IN RE: ESTABLISHMENT OF SECTION 16 IN THE CIVIL DIVISION
AND
REASSIGNMENT OF NON-DISPOSED AND REOPENED REAL
PROPERTY/MORTGAGE FORECLOSURE CASES TO SECTION 16**

WHEREAS, Section 16 is hereby established in the Civil Division as the Mortgage Foreclosure Project as a result of the Florida Legislature's authorization of additional funds to be utilized this fiscal year by the State Courts System to reduce the backlog of non-disposed and reopened real property/mortgage foreclosure cases; and

WHEREAS the Court has determined that both non-disposed and reopened real property/mortgage foreclosure cases from Sections 04, 07, 08, 11, and 15 should be reassigned to the newly created Section 16; It is, therefore,

ORDERED AND ADJUDGED that:

The Polk County Clerk of Courts (hereinafter "the Clerk") is hereby directed to reassign to Section 16 all real property/mortgage foreclosure cases filed prior to October 1, 2009, and all reopened cases originally filed prior to October 1, 2009, less and except those cases listed in Attachment A (which are cases currently set for a hearing), from Sections 04, 07, 08, 11, and 15. All cases filed after September 30, 2009, will remain in their current divisions.

This Order shall be effective upon signing.
