WHO MAY ENTER: Any individual student enrolled in a Highlands County public, private, or home school in Grades K-1, 2-3, 4-6, 7-8, and 9-12. First, second and third place winners will receive gold, silver, or bronze Olympic Style Medals, and be recognized at Law Day's televised award ceremony at the Highlands County Government Center.

Our Guidelines:

- Only individual student entries allowed.
- Please put your name and teacher **on the back** of the poster in pencil.
- Original posters must be submitted on **white 12" x 18" paper or poster board**.
- Any non-smearable medium is acceptable such as colored pencils, markers, crayons, or paints, (No glitter please.)
- We may publish the winning entry, and all qualified posters will be displayed at the Highlands County Government Center.
- No loose or hanging materials permitted.
- Each poster must depict the law day theme. A **one paragraph statement describing how the poster reflects the theme** is required on the back of the poster.
- All entries must be accompanied by the attached Student Entry Form, which will be removed prior to displaying the poster, so please do not adhere for permanency.

Deadline: Entries may be turned in any time during the year, but will not be judged until after the delivery deadline. **All entries must be received by Thursday, April 5, 2012, at 5:00 p.m.**

The Law Day Committee welcomes all entries that relate to the contest theme, however, the committee reserves, within its discretion, the right to disqualify any entry that is deemed to be offensive or not related to the theme of the contest.

CONTENT:

1. Must reflect the theme
2. Must be student’s individual work.

LETTERING: Lettering should be clearly legible.

JUDGING: The age of the participant will be considered. Other criteria for the selection of the award-winning posters are:

1. Clarity and readability of work
2. How well the theme was expressed
3. Artwork and execution
4. Visual impact of the poster design.

All due care will be used to protect the posters while they are on display, but the Law Day sponsors will not be held responsible in the event of lost, stolen or damaged posters.
